This Equipment Lending Agreement ("Agreement") is made between Almost Home Animal Rescue ("Lender") and the undersigned ("Borrower") for the temporary use of a cat/dog carrier ("Equipment").

**1. Rental Period:** The rental period shall commence on \_\_\_\_\_ (start date) and terminate on \_\_\_\_\_ (end date.) Rentals may be renewed in person, by email, or over the phone and must be requested on or before the scheduled return date.

**2. Description of Live Traps:** The Shelter agrees to rent to the Renter the following items, listed below, in good working condition:

### **4. Borrower Responsibilities**

- The Borrower agrees to return the Equipment in the same condition it was in when borrowed, with reasonable wear and tear excepted.
- The Borrower is responsible for the safe use and care of the Equipment while it is in their possession.
- The Borrower agrees not to modify or alter the Equipment in any way.
- The Borrower agrees to notify Almost Home Animal Rescue immediately if the Equipment is damaged, lost, or stolen.

**5. Return of Equipment**

The Borrower agrees to return the Equipment by the due date to Almost Home Animal Rescue at the designated location. If the Equipment is not returned by the due date, the Borrower may be subject to a late fee of \$\_\_\_\_\_ per day.

**6. Damage or Loss**

If the Equipment is damaged beyond normal wear and tear or lost, the Borrower agrees to reimburse Almost Home Animal Rescue for the cost of repair or replacement, up to the value of \$\_\_\_\_\_.

The Borrower agrees to indemnify and hold harmless Almost Home Animal Rescue, its employees, and volunteers from any liability, damages, or claims arising from the use of the borrowed Equipment.
